THE YEAR IN REVIEW



2019

THE WORCESTER REGIONAL RESEARCH BUREAU

is a trusted voice on a variety of critical issues facing Greater Worcester. We provide the needed information and perceptive analysis to the challenges and opportunities that our community faces in 2019 and the years to come. Our long-form reports, Bureau Briefs and Francis A. Harrington Forums identify the issues, analyze the data, recommend best practices, and disseminate the results. For this objective, non-partisan research and analysis, The Research Bureau is positioned as a wellrespected institution in Worcester and beyond.

Recurring Reports

Consistency and reliability are the hallmarks of a great organization. The Research Bureau is both. We delivered new installments in series the community has come to depend on over the years. The fifth edition of The Worcester Almanac provided statistics and data on every measurable facet of the community, mixing information from the national census with local facts and figures. This resource has been well-used by local media, other organizations, and the community at large. Breaking Down the Budget condenses complex and hard-tounderstand financial information from the City into a document the average citizen can use to gauge the priorities of their government. The 2019 edition of this report was especially important as the construction of a municipally-owned baseball stadium impacts Worcester's debt, spending concerns, and financial health. In an effort to maintain momentum on the Worcester Public Schools strategic planning process the Research Bureau led last year, a report on Chapter 70 reform was released, providing a local perspective to an issue receiving increasing statewide attention as more people come to grips with the underfunding of public education in the Commonwealth. The 31st Thomas S. Green Public Service Awards drew a large crowd to honor unsung heroes of local government, in Worcester and surrounding towns, who are not usually recognized in other awards ceremonies. The Research Bureau also maintained its position as the facilitator of the premier *municipal candidate* debates for local government in partnership with the Telegram & *Gazette* and the Worcester Regional Chamber of Commerce with assistance from venue partner Mechanics Hall, hosting events for races for Mayor, At-large City Council, District City Council, and School Committee.

The departure of Executive Director Timothy J. McGourthy at the beginning of the year did not stop the output of reports, briefs, and events due to the commitment and hard work of Research Bureau staff and volunteer leadership. After a thorough six-month search process that drew interest from numerous candidates, the Research Bureau was proud to welcome new executive director Paul F. Matthews.

While The Research Bureau focuses on public policy broadly, new work done over the course of 2019 can be grouped into a few areas of emphasis.

Transportation

The Implications of a Fare-Free WRTA took a deep look into the finances of the Worcester Regional Transit Authority, analyzed ridership trends, and used data and research to determine the feasibility of eliminating fares, and showing the potential beneficial impact. The Research Bureau challenged the conventional wisdom that raising fares is necessary for the financial health of a transit system by showing that the most recent fare hike actually decreased farebox revenue, and that fares accounted for less than 15 percent of the WRTA's revenue. The report combined financial data, ridership statistics, evidence from other cities, and existing research on transit policy to recommend prioritizing ridership by finding alternate revenue streams for roughly \$3 million in farebox revenue. This report sparked significant debate and has received frequent and ongoing media coverage. A group of transit advocates and community partners have used The Research Bureau's work as a starting point for a strategic campaign to further explore recommendations in the report.

The Research Bureau also explored using mass appeal and levity to focus public attention on transportation policy with the second season of "**Buck Bus**," a rolling game show that takes place on WRTA buses. Partnering with Niche Hospitality and the WRTA, the Research Bureau developed trivia questions about Worcester demographics, history, and characteristics, and gave bus riders the chance to win restaurant gift cards as contestants on this popular video program.

Economic Development

The Research Bureau addressed popular demand with **Opportunity Zones in Worcester: Characteristics of Worcester's Designated Areas**. Information on these new federallydesignated areas was scarce, but investor interest was high, so The Research Bureau produced dossiers on the six census tracts in question, using mapping technology and demographic information to paint a comprehensive picture of the zones. The report was used as the informational hand-out at a standingroom only Worcester Regional Chamber of Commerce event that brought in national experts to explain the concept to a local audience.

Realizing the importance of infrastructure and informed decision-making to the local economy, the Research Bureau hosted Smart Cities: Building a Nexus Between Technology and Urban Infrastructure, a forum that brought in experts from Boston to discuss the concept with decision-makers from Worcester, including the City Manager and his team. Shortly afterward, the City announced the launch of an Office of Urban Innovation that would address many of the goals espoused in the forum. The Research Bureau also explored the impact of and need for affordable housing in a brief on the Worcester Housing Authority, examining the current state of public housing in the city and moves that should be made to improve the situation. In order to ensure that Worcester receives the full and correct amount of federal money it deserves based on population. The Research Bureau participates in the city's Complete Count Committee for the upcoming 2020 federal census, identifying ways to ensure as many residents as possible answer the upcoming questionnaire. The resulting data is used as the basis for most Research Bureau reports and for the federal government to guide funding and policies.

Municipal Operations

In *Choosing a Better Voting System: The Argument for Ranked Choice Voting in Worcester and Beyond*, The Research Bureau examined how residents choose their elected leaders, and found that there may be better ways than the current plurality voting system used in City Council and School Committee races. This timely report came as other municipalities, the state of Maine, and candidates for President of the United States discussed or implemented the voting reform, and the Worcester-centric report drew praise from national advocacy groups for its thoroughness.

In an effort to assist in efforts to improve regional health outcomes, The Research Bureau maintained its involvement with the Community Health Improvement Plan, serving on targeted committees providing assistance to the city's efforts to create a healthier city. The Research Bureau also published a new edition of *March Municipal Madness*, allowing residents to fill out a tournament-style bracket of municipal priorities, which drew media interest, boosted the Research Bureau's profile among new audiences, and raised awareness of the issues facing the city.






